A Case Management Conference (CMC) was held by teleconference on September 11, 2015, at 1:00 P.M., Eastern Time (Ottawa).

[1] The Claimant shall serve and file its Brief on compensation with the Tribunal on or before **September 21, 2015**.

[2] The Respondent shall, within 14 days of receipt of the Claimant's Brief on compensation, provide a list of additional authorities on which it will rely on in the compensation phase.

[3] The next CMC will discuss whether a hearing on compensation principles will follow the delivery of the Claimant's Brief on compensation.

[4] The next CMC will be scheduled after the delivery of the Claimant's Brief.

[5] The Parties shall provide an agreed calculation of withheld treaty annuities to the Tribunal on or before the next CMC. The Tribunal's calculations based on the figures provided in the Agreed Statement of Facts at paragraphs 52-56 amount to a total of \$4,250, \$25.00 less than advanced by the Claimant's at paragraph 223 of the Claimant's Memorandum of Fact and Law dated September 3, 2014.
